Kenny Schares, HOA president, and several property owners from the Sunset Acres rural subdivision were present to discuss changes to the mutual aid agreement with the City of Jesup for fire protection for their section. They requested the Jesup Fire Department be paged at the same time as the Brandon Fire Department because Jesup was closer to their housing addition. K. Thomas informed the property owners that the Brandon city council did not make decisions for the Brandon Fire Department, but she would discuss their request with the Brandon Fire Department at their next meeting.

Motion by Brown, second by B. Thomas, to approve the installation of two solar powered lights for the basketball court in the park. All ayes. Motion carried.

Motion by K. Thomas, second by Routier, to approve installing a storm sewer intake in the ditch in front of 903 Main Street. All ayes. Motion carried.

Motion by Routier, second by Brown, to approve the purchase of a Lexmark XC4342 from Gordon Flesch, Inc. in the amount of \$2,238.00, and to enter into a service agreement with Gordon Flesch, Inc. for the equipment. All ayes. Motion carried.

The public works director reported the parking brake on the Case tractor is broken and will need to be repaired. The city council requested he get quotes to transport and repair the tractor. The city council also discussed requesting quotes to wash the exterior of the water tower.

The city council discussed tiling on private property, scheduling an exam for wastewater certification, building addresses, and the status of the sewer repair on Main Street. The city attorney will send the property owner a bill for the sewer repair on Main Street.

The mayor reported a streetlight was knocked over in the park. The mayor was contacted again by a girl scout leader regarding the installation of a portable shed in the park to store equipment. The city council does not want a portable metal shed in the park.
