The city council discussed the cost of repairs to a sanitary sewer service at 404 Main Street. The city council agreed to direct the city attorney to send bills for the repair to the property owner.

The city council discussed dangerous building abatements sent to 606 Main Street and 707 South Street. Court dates have been set for both properties. The city may need to discontinue the abatement for 606 Main Street if the property has been sold.

Motion by Routier, second by K. Thomas, to approve Resolution 2022-1101: Resolution Approving the Hiring of City Clerk/Treasurer And Setting Salary. Ayes: Routier, B. Thomas, K. Thomas. Nays: None. Motion carried. Kandi Tesar will receive a performance review after six months. The City will provide training as needed. Office hours will be 1:00-5:00 PM on Monday and 8:30-12:30 & 1:00-5:00 on Tuesday and Thursday.

Motion by K. Thomas, second by Routier, to approve Resolution 2022-1102: Resolution Entering Into a Water Utility Vendor Agreement With Operation Threshold For The Low-Income Household Water Assistance Program. Ayes: Routier, B. Thomas, K. Thomas. Nays: None. Motion carried.

Motion by K. Thomas, second by B. Thomas, to approve the liquor license for Phat's Pub and Grub. All ayes. Motion carried.

Public works employee Joe Enos reported the truck is ready to plow. He will get bales of straw to cover the water main in the ditch.

The mayor reported a parcel of land near the bike trail will be coming up for auction. Buchanan County Conservation inquired if the city would be interested in purchasing the property for a park and offered to assist with a REAP grant if the city purchased the property. The city council was not interested in purchasing the property at this time.

The city clerk reported on two budget training opportunities.

Motion by K. Thomas, second by B. Thomas, to adjourn the meeting. All ayes. Motion carried. Meeting adjourned at 6:30 PM.
